Part 1: PSLS & Review Basics (2.5 hours)

In this interactive workshop, attendees will refresh and increase their understanding and practice of managing PSLS Level 1-3 ('no harm' to 'moderate harm') patient safety incidents. PSLS Coordinators and Patient Safety Consultants will co-facilitate this workshop, answer your questions and explain how we work together to assist you to handle patient safety incidents.

Learning Objectives: By the end of this session, attendees will be able to understand:

- What steps are required when you area assigned as a Handler of a PSLS patient safety event
- The guiding principles and steps of conducting a patient safety incident review
- · How to identify and document the findings and recommendations of your review
- How to ensure all elements of a review are captured prior to closing a PSLS file

Part 2: Patient Care Quality Office (1.5 hours)

In this session the Island Health Patient Care Quality Office (PCQO) shares an overview of the purpose, review processes, and support services provided by the PCQO team.

- The purpose of the PCQO
- How the PCQO can support you and your team
- The difference and similarities between a PCQO Review and a Patient Safety Incident Review
