Medical Staff Practice Description Tool Frequently Asked Questions (FAQ)



What is the Medical Staff Practice Description Tool?

The Medical Staff Practice Description Tool is a workload data collection form that has been developed to gauge the multifaceted nature of the departmental commitments, and to better detail how each individual medical staff member organizes their work to contribute to patient care.

This tool will allow medical department and division heads to be better informed regarding all medical staff members. The information you provide will enable departments to identify gaps in current service provision, including those that occur when a member leaves or changes their practice, and determine overall workloads. Ultimately, this information will help inform future medical staff human resource planning.

What information are you asking me to provide?

The Medical Staff Practice Description Tool asks questions in 5 categories:

- 1. Core: call coverage, operating room, inpatient care/on-service, private office/general clinics
- 2. Teaching: classroom, clinical practice
- 3. Administrative duties: Division Head duties, Medical Lead duties, designating call schedules, meetings, etc.
- 4. Outreach: outreach work for communities in each of the 4 Geos
- 5. Specialty clinics in hospitals, health centres, clinics and community

Why is this work being done?

Proactive, collaborative medical staff workforce planning benefits patients, practitioners, the public, healthcare organizations and government by anticipating change rather than reacting to it. This improves our ability to avoid gaps in service to patients and crises in workload and coverage for medical staff.

Accurate knowledge of the current state of medical staff human resources is essential to understand what changes are needed within a department to ensure a healthy, productive medical staff that can deliver quality patient care across Island Health.

Why should I participate in this initiative?

The Medical Staff Practice Description Tool was created to improve our understanding of medical staff care coverage, including the work that you do in specialty clinics and in the community. We understand that each of you have a unique and individualized practice. This tool was designed to help us better recognize how individual practices contribute to medical care in Island Health.

The information you will provide is critical for our communities – it is our responsibility to plan for effective and continuous coverage of health care needs for Vancouver Island residents. The results of this data collection will provide invaluable information for future workforce planning, anticipating future needs, and allowing individuals to evaluate and reflect on their own workload balance.

How long does it take to complete the form?

The Medical Staff Practice Description Tool should only take about 5-10 minutes.

Who developed the Medical Staff Practice Description Tool?

The Practice Description tool was developed and endorsed by medical staff members of the Medical Planning & Credentials Committee (MPCC), where it has since received feedback and approval from each of the Department Heads as well as the Medical and Academic Affairs Leadership team.

Who is being asked to participate?

All current medical staff with privileges at an Island Health facility will be asked to participate. The Medical Staff Practice Description Tool will be rolled out on a department by department basis.

How do I access the Medical Staff Practice Description Tool?

All medical staff will be sent a unique link with an invitation to participate. Medical staff will have 8 weeks to respond. A reminder to participate will be sent each week after the first week to individuals who have not completed the form, and follow-up calls will be made by Medical and Academic Affairs staff.

What do I do if the link doesn't work?

How is the data being collected/stored?

The data is being collected through Checkbox, a data collection application that is housed on servers internal to Island Health, which allows for increased privacy and security.

Practice information will be collected and analyzed by Michelle Riddle (Decision Support) with support from Medical and Academic Affairs. Individual responses will only be available to the Department Heads for workload/human resource planning discussions within your team, Medical and Academic Affairs staff for developing practice descriptions and Decision Support for technical assistance and data stewardship.

How will my responses be used?

The information that you provide will be used for three purposes:

- 1. For your local community of practice: This data will guide your discussions with your division/department head in terms of your workload and workload balancing within your team. Your information will be provided at an individual level.
- 2. **For Medical & Academic Affairs:** Medical and Academic Affairs will create a practice description that provides an accurate summary of your clinical practice inclusive of workload. This practice description will support you and your colleagues in effective workforce planning and projections when considering locum coverage, temporary staff member need, members choosing to alter their workload in a specific way, and succession planning to support transition to retirement.
- 3. **Island Health's medical staff workforce plan:** Aggregate, or rolled-up information without individual details will be used at the geography or department level to estimate the size of the medical staff required to satisfy population health needs. This report will be provided to the Board, as defined in the Medical Staff Bylaws, and shared with the Ministry of Health to inform decisions about training positions and provincial medical recruitment priorities.
