COVID-19 Vaccination:

• mRNA Vaccine Effectiveness (VE): 1st Dose

Research led by Dr. Danuta Showronski and the BCCDC team provides BC estimates that show how effective a single dose of mRNA vaccine is when it comes to protection against the Gamma variant. The study period focused on is April - May 2021, during the peak Alpha and Gamma variant wave in BC. Community-based, 70+ year olds, was the population for this study.

Updated: Second dose considerations for those who received AstraZeneca or COVISHIELD for first dose COVID-19 immunization

The updated recommendations are based on current evidence and NACI's expert opinion. People who received AstraZeneca or COVISHIELD vaccine for their first dose may be offered the option of receiving either AstraZeneca or an mRNA vaccine (Pfizer-BioNTech or Moderna) for their second dose. Current evidence suggests a first dose of the AstraZeneca vaccine followed by a second dose of an mRNA vaccine (Pfizer-BioNTech was used in studies) is safe at shorter (4-week) and longer (8-to 12-week) intervals.

B.C. shifts to Step 3 of restart plan

With British Columbians achieving nearly 80% adult Dose 1 vaccine coverage and COVID-19 case counts continuing to decline, the Province is safely moving to Step 3 of its four-step restart plan on July 1, 2021.
