## COVID-19 Vaccination Information:

- [\*\*Mandatory Vaccination for Medical Staff and Healthcare Workers\*\*](#)

A message from Dr. Mike Benusic about mandatory COVID-19 vaccination for all healthcare workers.

- Dr. Bonnie Henry announced Monday that BC will mandate COVID-19 vaccines for workers in all health-care facilities. This includes all workers, physicians, residents, students, contractors and volunteers in hospitals and community settings – both public and private. This new PHO order is to come into effect on October 26th, and the PHO order will be shared in the medical staff bulletin once available.
- Provisions of the [existing PHO order for Long-term care, Assisted Living and tertiary mental health sites](#) (Seven Oaks, Cowichan Lodge and Ledger House) come into effect tomorrow.
  - Between Sept 16-Oct 23, any medical staff member who is not fully vaccinated will be required to undergo point of care test for COVID-19 before entering a facility covered by the order.
  - As of October 24, unvaccinated health care providers, including medical staff, will not be allowed access to facilities covered by the order.



- [\*\*A third dose of COVID-19 vaccine: People who are moderately to severely immunocompromised\*\*](#)

Some people do not develop a strong immune response from two doses of vaccine because of the use of certain medications and treatments, as well as some health conditions. For this group, it takes an additional dose to have a reasonable level of immunity and protection against COVID-19. This page explores who is eligible for a 3rd dose, how to get a 3rd dose and the difference between a 3rd dose and booster shot.
