### **COVID-19 Mandatory Vaccinations for Medical staff:**

As a reminder, on September 13, 2021 the Provincial Health Officer (PHO) announced that all employees, medical staff and other service providers who work in identified care locations in the health sector will be required to be vaccinated against COVID-19 by October 26, 2021.

On October 14th, Dr. Bonnie Henry issued this [public health order](#). The order provides an opportunity for current medical staff who are not yet vaccinated to continue working from October 26, 2021, onward, if they receive their first dose by no later than October 25, 2021, as follows:

- You must receive Dose 1 by no later than October 25, 2021;
- You must receive Dose 2 between 28-35 days after receipt of Dose 1 to remain eligible to work;
- You must continue to follow preventive measures (wearing a medical mask at work except if consuming food or a beverage), until you are 7 days past receipt of Dose 2 of vaccine.

Unless you are vaccinated as required under the PHO Order, or you have made a medical [exemption request to the public health order](#) that has been confirmed as approved or pending, you will not be able to provide services with Island Health from October 26, 2021, onward.

- [\*\*Hospitalized Patient COVID-19 Vaccination Procedure\*\*](#)  
This procedure clarifies providing COVID-19 vaccinations to eligible inpatients in acute care facilities. This is only for RJH, VGH, SPH, CDH, NRGH, WCGH, CVH AND CRH Island Health acute care facilities.
- [\*\*Updated: Guidance Document on the Management of Inadvertent Vaccine Errors\*\*](#)  
This guidance document goes into details on what to do if a COVID-19 vaccine is administered incorrectly, how to report it and how to prevent it from happening again. Vaccine administration errors can include wrong injection sites on the body, patients younger than approved (updated to 12 year olds being approved), two doses given too close together, higher dose than authorized and more.
