

**January 31 Deadline: Adoption of New Mental Health Act (MHA)
Forms 4.1 & 4.2

Proper Mental Health Act Form completion is a crucial part of protecting the rights of patients certified under the *Mental Health Act* and is required by law. **All B.C.** health authorities are required to implement the new Mental Health Act medical certificates (Form 4.1 and Form 4.2) by January 31, 2024. The old medical certificate (Form 4) will no longer be legally recognized effective February 1, 2024. Cerner EHR Applications Outage Scheduled for February 9-10

Our Cerner Millennium application will be undergoing an important upgrade as it transitions from our current data centre hosting to an Oracle Health hosted Canadian Data Center. This will affect all Cerner applications at Island Health. Within Island Health, this project is commonly known as the Remote Hosting Option (RHO).

When will the change take place?

From Friday, February 9, 10 p.m. to Saturday, February 10, 6.a.m.

Why is this happening?

This upgrade ensures the continued security and reliability of Island Health infrastructure and services.

How will medical staff be prepared and supported?
