

### COVID-19 Update #12

### Situational assessment:

- COVID-19 daily incidence in Island Health has doubled so far in 2021. The rate of growth has decreased, with a recent plateau of the 7-day moving average of daily cases.
- Currently, the Health Service Delivery Area with the highest rate of cases is Central Island, and within Central Island most cases are in the Greater Nanaimo Local Health Area. Information on COVID

- 7-day lab testing percent positivity has increased to 3.5%, which is explained by both a rise in incidence and testing rates ~2/3 that of early December. >95% of those calling into the Call Centre continue to be tested within 24h. For clients requiring COVID-19 testing but are unable to attend a testing site in-person, mobile testing may be available. Either direct clients to make this request when booking a test, or call 1-844-901-8442 on their behalf and request mobile testing.
- During January, 45 Island Health cases were admitted to hospital (6.1% of all cases • identified during the month). Of these, 13 were admitted to ICU. 9 deaths occurred in January. Nearly half of all total COVID-19 associated hospitalizations and deaths in Island Health occurred during January.
- The procedure for discharging COVID-19 inpatients has been updated at • intranet.viha.ca/pnp/pnpdocs/discharge-suspected-confirmed-covid-19-patients.pdf. If planning discharge of a patient who is still infectious, the Case and Contact Management Team (supported by the Medical Health Officers) must be involved to ensure isolation and monitoring in the community.
- COVID-19 cases continue to be contacted well within 24h of notification of a positive test ٠ result, and contacts are typically traced and managed within 24 hours as well. Cases and contacts receive virtual follow-up until they have successfully completed required periods of self-isolation or quarantine. Please note: this monitoring is predominantly for public health reasons (to ensure isolation and determine if contacts have developed symptoms), and does not replace clinical care. For select COVID-19 cases requiring a higher level of monitoring in the community, Intensive Home Monitoring is available upon referral: intranet.viha.ca/departments/hcc/hcc\_index/Pages/ihm.aspx
- The majority of cases in Island Health continue to have an identified source of infection, • with most linked to a known case or cluster.

# Vaccination

Updates:

- More than 27,000 doses of COVID-19 vaccine have been provided within Island Health, including all eligible and consenting long-term care and assisted living residents and staff.
- The current focus is on "Hospital health care workers who may provide care for COVID-19 patients in settings like Intensive Care Units, emergency departments, paramedics, medical units and surgical units", as per provincial prioritization accessible at <a href="https://bit.ly/365whh">bit.ly/365whh</a>. Plans are well underway for Phase 2 of vaccine roll-out.
- Many physicians have offered to aid in providing vaccines thank you! Right now, the limiting factor is vaccine supply, not the number of immunizers. The best way to support is by continuing to provide:
  - Patient guidance (see previous MHO newsletter: <u>bit.ly/3jDwMW7</u>)
  - Medical management and reporting of adverse events following immunization (see previous MHO newsletter: <u>bit.ly/3tDIPsd</u>). As a reminder, the determination of eligibility for future doses lies with public health upon review of an AEFI.
  - The BCCDC has released a statement on evidence supporting the deferral of second dose: <u>bit.ly/2Z0Pa1y</u>. A deeper dive into the evidence is provided in a presentation from Dr. Danuta Skowronski, viewable at <u>bit.ly/3p26Btb</u>. Currently, second doses are being booked at 42 days after the first.

# Variants of Concern

- Variants of concern are specific SARS-CoV-2 variants that are flagged as being potentially more transmissible, virulent, and/or less likely to be protected against by current vaccines.
- A summary of these variants from the US CDC can be found at <u>bit.ly/3tJ3Kcu</u>.
- Four cases of the B.1.1.7 variant have been detected within Island Health, associated with two returning travellers and two contacts. Surveillance for variants of concern continues.
