PRODUCT: N95 Respirator, 1870+, 3M

Who is Impacted: \square FHA \square IHA \square NHA \square PHC \square PHSA \square VCH \square VIHA

Specific sites/units: Staff who have a current fit-test on the 3M 1870+ N95 respirator AND have not been successfully fit-tested to an alternative respiratory protection device.

ALTERNATE PRODUCT:

- The clinically approved replacement is the Allmed KN95 Model P220002.
- This model is an equivalent to an N95 respirator. Supply Chain and health authority subject matter experts
 have reviewed and assessed this product for acceptability. It has undergone and successfully passed third
 party laboratory testing for filtration ability and fluid resistance at SGS IBR Laboratories, UBC Department
 of Mechanical Engineering, and Mustang Survival.
- <u>Fit-testing is required</u> for the alternate product.
- Health and Safety has identified and will be contacting specific departments to begin the transition and fittesting to the alternative product.
- Staff who do not fit the Allmed KN95 model P220002 may be fit-tested on additional respiratory protection devices.
- In the meantime, and if you are not otherwise informed, continue to use the 3M 1870+ model as per established procedures.
- The replacement product will be allocated to the Health Authorities, for the Health Authorities to distribute as fit-testing is completed.

PRODUCT SITUATION:

- PHSA Supply Chain has been notified that the 3M 1870+ N95 respirator (Product code 355-1870+) is not currently available in Canada due to distribution restrictions imposed by the US on 3M related to the COVID-19 pandemic.
- Health Authority order numbers are provided below.
- Backorder resolution date is unknown at this time.
