

## **October 6, 2021 – Mandatory Vaccination Coming for All Healthcare Workers in British Columbia (BC)**

In yesterday's provincial briefing, Dr. Bonnie Henry shared updates around an [updated mandatory vaccination public health order](#) (PHO) impacting long-term care and assisted living sites in British Columbia (BC). The order takes effect Tuesday, October 13<sup>th</sup> and changes include:

- Visitor vaccine requirements:
  - Visitors to long-term care, assisted living and tertiary mental health sites will be required to be fully immunized – and show their vaccine passport – effective October 13; and
  - Visitors to acute facilities will be required to be fully immunized – and show their vaccine passport – effective October 26. Some non-vaccinated visit exceptions granted for palliative or end-of-life care.
- A provision to allow health care workers who get their first dose by October 12th to work, with preventative measures in place and a commitment to get their second dose 28-35 days after their first dose.

The order for the mandatory vaccination of the broader health care sector and healthcare workers outside of long-term care and assisted living is still under development, with consultation taking place with HEABC, unions, health authorities, colleges of physicians and nurses and others who are affected. Dr. Henry says the consultation process is in the final stages, and the order will be posted in the next few days so people can see the details. We are waiting for clarity on the:

- process for medical staff seeking exemptions;
- work restrictions for medical staff who are only partially vaccinated;
- definition for healthcare workers and their relationship to and interactions with Island Health facilities; and
- Provincial direction on consequences for non-compliance with the Order.


Dr. Richard Stanwick shared at this week's Staff and Medical Leadership Townhalls that all COVID-19 cases in Island Health are the delta variant, and of hospital cases 91% are unvaccinated; we are currently seeing ~70-80 new cases per day this week in Island Health region.

### **COVID-19 Testing for Primary Care Providers and Healthcare Workers**

- A reminder to all primary care providers that our priority call line is still in service. If testing is recommended, symptomatic care providers (including primary care and subspecialty providers) can access priority COVID-19 testing by calling 1-833-737-9377 – seven days a week - 8AM - 4PM. Our call centre will slot you into the next available spot.
- If you have symptoms and you feel ill, please stay home. As we head into the fall, we all must remain vigilant to keep COVID and its variants – as well as other respiratory viruses – out of our offices and communities. Please note: priority testing is only available to care providers. Family, friends and office staff are required to continue using the general call centre line: 1-844-901-8442, daily from 8AM-4PM.
