What is the IHealth Medical Staff Champion Council (MSCC)?

- The MSCC is comprised of over 40 members of Island Health's medical staff, who have joined the IHealth team to represent their specialty in the preparation work for a successful CPOE activation.
- The MSCC meets monthly to review project updates and expected practice changes with CPOE in order to share this information with their colleagues as we all prepare for the CPOE activation.

Greater efficiency with use of controlled substance printers

Nanaimo Regional General Hospital is tentatively targeted for roll-out of controlled substance prescription printing in late fall 2023, while other facilities will go live at the time of their CPOE roll-out.

Entering orders for controlled substances electronically ensures that the electronic health record is comprehensive and includes documentation of all medications, including controlled substances, while ensuring safety precautions with tamper-proof prescriptions.

Workflow Validation Updates

Workflow validation sessions continue through the summer

The IHealth team is confirming dates and continuing workflow validation sessions through the summer. Many medical staff will be invited to participate in remaining sessions to ensure a successful Go-Live in February and March 2024. Be on the lookout for an email inviting you to join an upcoming session.

To date, 196 providers have attended 11 workflow validation sessions, including the following streams: perinatal, rehab, mental health and substance use, surgical services and more.

Recap of All-Physician Workflow Validation session, June 29

Clinical Informatics and IHealth hosted an All-Physician Workflow Validation session June 29, walking participants through key patient transitions in care in order to review and validate the future state electronic workflows.

The group reviewed an admission from the emergency department through to discharge home, discussing orders management, medication reconciliation and more. The session also provided an opportunity to see the workflows of supporting team members/departments, such as lab, pharmacy and nursing.

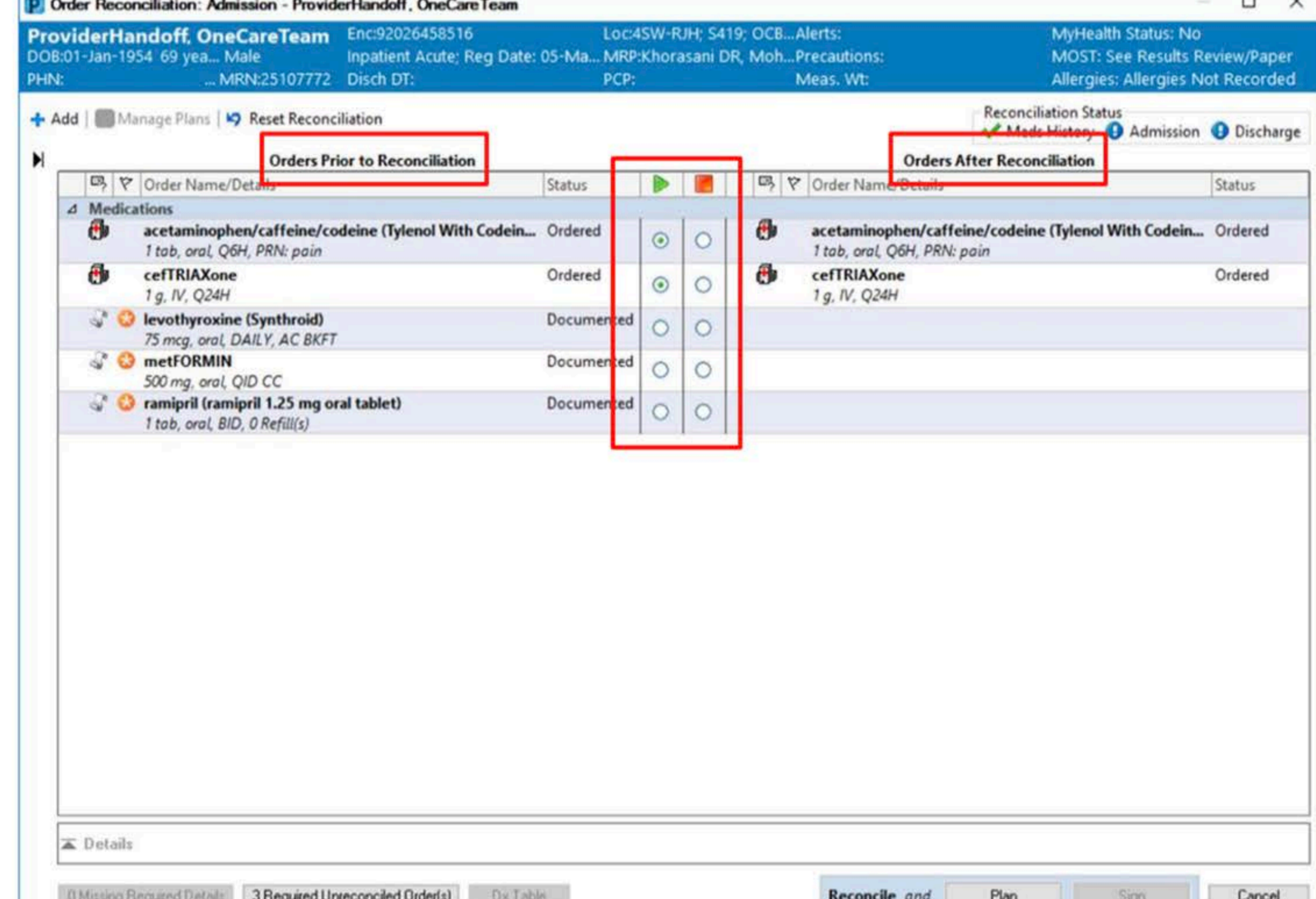
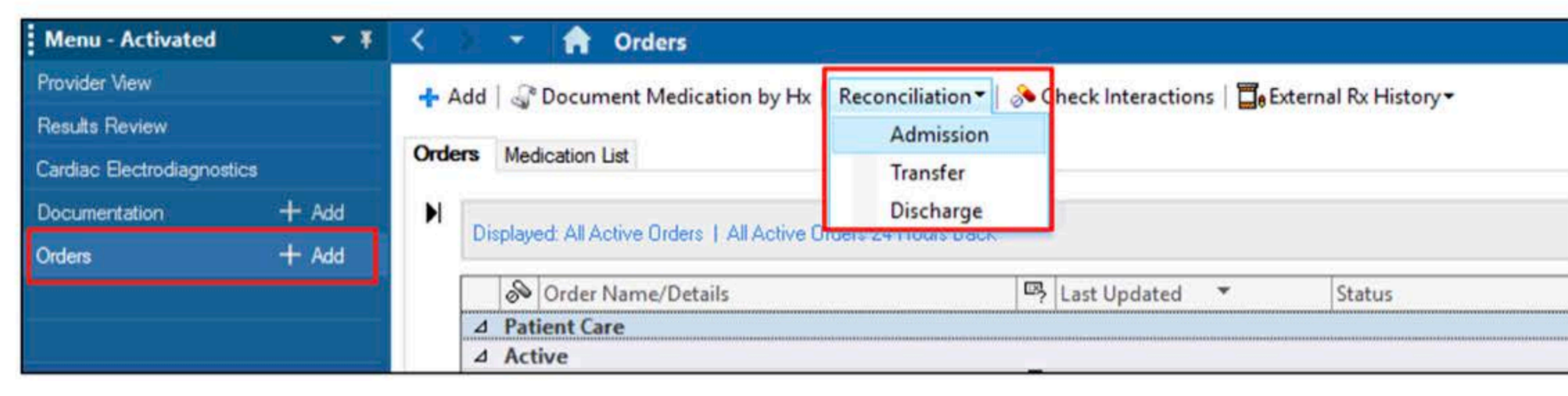
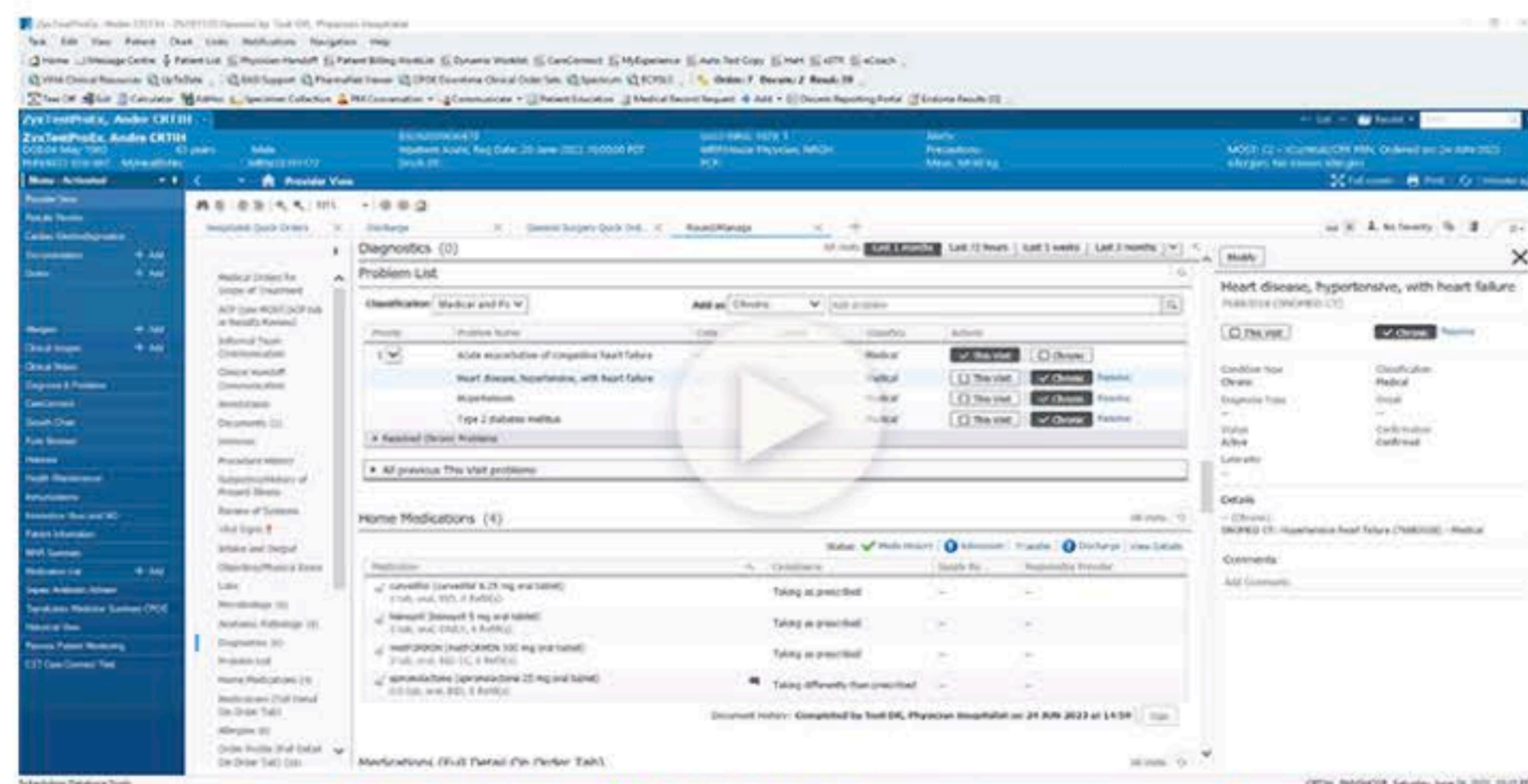
Session participants identified gaps as well as changes in practice and policies, which the IHealth team will address in partnership with clinical operations.

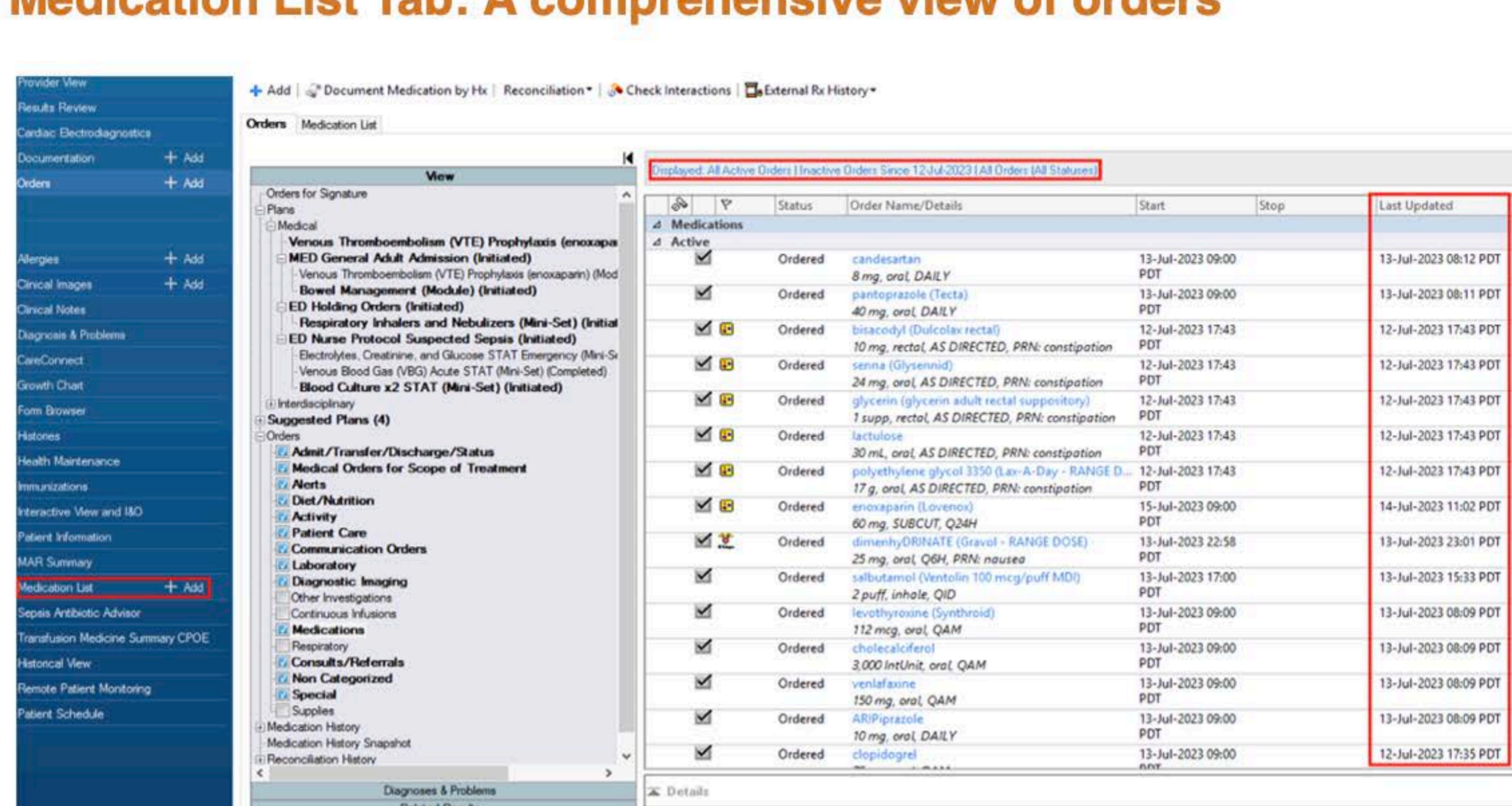

FAQs

Here are some questions we have received recently from medical staff:

Q: Will IHealth permanently make our ambulatory clinic less efficient?

A: With any significant change in workflow, processes change, especially temporarily when there is a learning curve for the entire care team. Overall, processes, end to end, improve clinic efficiency and the quality of care.

Q: Do we have a different version of Oracle Cerner than what is used in the U.S.? Is our version a "cheap" or "old" version?

A: Oracle Cerner solutions are kept relatively the same across B.C. health authorities, and, in turn, those are relatively comparable across Canada.

Some niche or localized solutions differ across health authorities as they come on-line; in that sense, no two health authorities will be exactly the same (e.g., some health authorities have Oracle Cerner patient portals, while others don't).

That said, Oracle Cerner's solution set is used internationally in the U.S., U.K., Australia, Canada, Asia and South America. Oracle Cerner makes some solutions and solution-enhanced components available to its U.S. market ahead of its international markets.
