### Launch the MHSU Services Regional Orientation Curriculum

The MHSU Regional Orientation Curriculum will be launched by the Clinical Practice Support Team on March 1, 2022. A regional orientation curriculum was identified by the MHSU Quality Council as a priority, and is a key deliverable in the 2021/2022 MHSU Strategic Plan.

The MHSU Regional Orientation Curriculum is intended to:

- Welcome new MHSU team members
- Build upon the New Employee Orientation curriculum
- Support job readiness for the MHSU system of care
- Intended to complement local program specific orientation
- Support team members to provide high quality service

The curriculum is organized into three key areas: providing care, safety, and employee wellness. Examples of topics are: Cultural Safety and Humility; Recovery Oriented Practice, and Harm Reduction.

This launch is a major milestone as the first regional practice support delivered by the Practice Support Team as part of the <u>Quality and Clinical Networks portfolio of the MHSU Strategic Clinical Network (SCN)</u>.

## Cognitive Behavioural Therapy (CBT) Skills Groups



The CBT Skills Groups Society is a non-profit society formed by a team of family physicians and psychiatrists, the Board of Directors, and the staff. They operate with the ongoing support of the physician facilitators and a partnership with Island Health.

The Cognitive Behavioural Therapy (CBT) Skills Groups are an 8-week program open to all BC residents with a valid Canadian health card number. The course is designed for

adult patients (17.5 years and up) who want to learn practical tools to improve their mental health. Designed by psychiatrists and taught by physicians this course integrates neuroscience, mindfulness, and cognitive behavioural therapy skills and concepts.

Additionally, as of September 2021, they have partnered with the Shared Care Committee and the UBC Office of Continuing Professional Development to support physicians in BC to take the course, to better support their own health and those of their patients. They also train more physician facilitators as part of this program, so that physicians can offer the groups online and eventually in-person, across BC.

### MHA Tracking & Database Orientation eLearning Module

A new eLearning module for the Mental Health Act (MHA) Tracking & Database Orientation is now live! The MHA Tracking & Database work supports the patients who are receiving involuntary treatment under BC's *Mental Health Act*. This module will provide the necessary form review and database orientation support to the unit clerks and other roles that have been designated for this work by their Site Leadership. Over the course of one hour, the module guides learners through narrated slides and data entry video demonstrations.

At the end of the module, a quiz must be completed with a minimum grade of 80% to satisfy the course completion requirements. A PDF of the Record of Completion can be downloaded and sent to your unit or program leadership.

To take the MHA Tracking & Database Orientation (Course #27471) *one of the following* prerequisites need to be completed:
