Island Health Launches Overdose Prevention Campaign Aimed at Men

The drug poisoning crisis has claimed the lives of more than 1,417 Island Health residents since this public health emergency was declared in 2016. Tragically, the devastating and preventable loss of lives due to drug poisoning continues and disproportionately impacts men aged 30-59.

On April 4, Island Health is launching a three-week overdose prevention campaign aimed at men who are at-risk of injury and death caused by the toxic drug supply. The goal of this campaign is to increase awareness about the range of harm reduction services that can help people stay safer when using substances. These include drug checking, substance use safety apps such as Lifeguard and Brave, Take Home Naloxone and supervised consumption and overdose prevention sites. One of these individuals recently presented the team with a letter which was read aloud. Here is an excerpt of what was shared:

"I would love to commemorate, commend, and honour those of you that put your lives out there to help [those] in dire need of help... mentally and physically... the unfortunate, the hurt, and sometimes the forgotten.

Everyone who "works" on the team is here because they themselves care... it has been an absolute treasure and honour to have met and talked with those of you I now know.

I myself do not believe in the bible ... but I do believe in angels and angels walk among us and you are them, with hidden wings, halos and hearts. I thank you for being the wonderful you that you are and I believe in you. Thank you! I now have another story to tell because of the angels among us."

Launch of the ACT Clinical Network

The ACT Clinical Network launched in February 2022!

Clinical Networks are one of the core functions of the MHSU Quality Clinical Network. Clinical Networks bring together staff with expertise and experience in key subject and service areas, and serve three purposes:

- 1. Identify and inform quality initiatives, service evaluation, and practice standards;
- 2. Support knowledge exchange; and
- 3. Create a community of practice and through a standardized and transparent process.

Participants of the ACT Clinical Network shared appreciation of networking with their regional colleagues. Early ideas for how the network will influence quality include: standardization around rent subsidies, money management, and documentation practices.

Every Clinical Network meeting closes with a brief but important survey to ensure the network is meeting the needs of participants. The ACT survey indicates participants felt that the group is launching in a way that supports learning, connections, and adds value to work!
