



What is this Training Program?

Physician Quality Improvement (PQI) Cohort training is a professional development and education program for community-based and facility-based specialists, family physicians, nurse practitioners and midwives. *Island Health privileges are not required*. The PQI curriculum was specifically designed by Medical Staff for Medical Staff to give you tools you can apply in real time.

It is the only Quality Improvement (QI) education program that offers:

- In-person and virtual workshops across Vancouver Island
- The opportunity to practice the methodology by leading your own QI project with a team
- Dedicated support from experienced physician mentors, staff coordinators and data analysts
- Mainpro+ and Mainport section 1 CME accreditation for over 50 hours
- Up to 158 hours of JCC-rate funding (approx. \$27,000) for physicians licensed in B.C.

NB: There are many approaches to improving quality in healthcare (e.g., research, quality assurance, and quality improvement). QI is best applied to improve existing systems and processes where you have a great deal of flexibility in *how* a gap in care can be addressed. QI focuses on improvement without net new resources.

 If you already have a solution and are looking for support on how to implement it, or are looking for funding support for a capital project or new service, you may be better served by service design or project management methodologies that are outside of the mandate of this program

What are the Application Requirements and Commitments?

Requirement 1: Mandatory Attendance at Workshops and Graduation Events

- **6** in-person workshops (three 2-day events) Workshop travel and accommodation costs are covered for travel greater than 50km
- 5 virtual workshops (Zoom)
- 2 evening graduation events (attending the Cohort 9 graduation in October 2025 and your own in 2026)

Requirement 2: Dedicated QI Project Time

- You will spend an average of **3 hours of project work per week** in addition to the time at the workshops (with September, October and June generally being the busiest as your QI project launches and closes)
- In between workshops, you will have coaching sessions with PQI team members who will make sure you
 are on-track for meeting your learning objectives and project requirements

Requirement 3: Leading and Documenting a QI Project

In this training program, you will lead a QI project of your choosing, and commit to:

- Assembling a local QI team
- Applying QI tools to understand the gap in care and project aim
- Developing a QI Project Charter
- Using data and designing measurement plans
- Engaging with key partners and sponsors throughout the project
- · Working alongside a patient partner
- Sharing your project by way of a graduation presentation and poster, and summary report





Requirement 3: Leading a Quality Improvement Project continued...

 Championing QI within your community and department and sharing your knowledge and tools with your colleagues

Who is Eligible?

- All community-based and facility-based licensed physicians in the Island Health region
 - Note: Active privileges with Island Health are not required
- Island Health Nurse Practitioners (NPs) and Midwives
 - Note: Neither expenses nor sessional funding is provided for NPs or Midwives as funding for PQI comes from the Physician Master Agreement

How will Cohort 10 Learners be Selected?

An interdisciplinary Admissions Committee consisting of patients, Island Health administrators, Specialist Services representatives, clinically active physicians and PQI Program staff will select top applicants based on the following criteria:

Applicant (70% weight). Considerations include:

- Does the applicant demonstrate a passion and mindset that would contribute to a successful learning experience?
- Is there a focus on engaging and empowering patients as part of the application?
- Is there a demonstrated interest in learning about and applying Quality Improvement science to address a gap in care?
- What is the aptitude for building and participating in teams¹?
- Does the applicant bring a unique or diverse perspective to the program?

Area of Interest (30% weight). Considerations include:

- Does the applicant describe potential to improve healthcare quality in a measurable way?
- Is there a focus on improving dimension(s) of quality from a systems' perspective (as per the <u>BC Health</u> Quality Matrix)?
- What is the level of readiness² in the program area or clinical context for a QI project?

What is the Application Process?

If you can commit to the application requirements listed above, here are some key dates for you to know:

¹ In the context of QI, team members can include, but are not limited to, Medical Staff, Medical Office Assistants, Nurses, Patient Partners, Unit Clerks

² Level of readiness can include, but is not limited to, other concurrent changes being implemented, staffing, workload, sphere of control





What is the Application Process? continued...

The application form is digital (administered through an online survey), and requires that you submit the following information:

- Applicant and contact details
- Previous QI experience or training
- Motivation and expectations for the program
- Details of the healthcare problem/gap in care that you hope to address with your QI project
- Level of engagement with key partners*

Based on the content in the application form, candidates will be shortlisted and booked for a 30-minute dialogue with PQI Leaders to discuss the PQI program and your area of interest for your QI project.

*Any QI projects that include Island Health staff or resources require that an Executive Sponsor³ and Operational Sponsor⁴ have been identified and preferably engaged prior to this application. This is to help identify any strategic alignment the PQI project may have with existing Island Health or Ministry of Health priorities, and to ensure you have support to engage with Island Health staff as part of your QI project team.

³ Executive Sponsors are individuals well positioned to ensure your PQI experience is successfully integrated into clinical operations. At Island Health this is usually an Executive Director (ED) or Executive Medical Director (EMD) of a geographical (local) health area (e.g., Nanaimo) or of a program (e.g., surgery); in a community clinic or individual practice this may be the Medical Lead of the practice, or where the project lead does not require an Executive Sponsor for successful integration, we suggest engaging with a colleague with a similar practice.

⁴ Operational Sponsors are typically those individuals who are directly responsible for the staff you need to involve in the QI project. At Island Health this is usually a Coordinator or Manager who can make local staffing and budget decisions; in a community clinic or individual practice, this can be an Office Manager or other similar roles.
